### **GRAVE MARKERS IN LIMBO**

Mike Whistler is facing a grave problem.

The 28-year-old self-employed laborer has been left with 130 grave markers emblazoned with the names of dead children.

"I think someone should lay them to rest properly," he told The Province yesterday.

Whistler said he was paid \$100 by a developer in November to remove the markers, which had been used to make a path to a Coquitlam four-plex.

“He didn’t tell me what they were but when I turned them over I saw the names.” said Whistler.

The Saddle Street four-plex has been bedeviled by strange noises, moving beds and erratic TV’s. tenants are convinced the residence is haunted by ghosts.

The sight of a groaning headless monk sent tenant Dawn Hutton fleeing into the night with her four children two days ago, vowing never to return.

Whistler was planning to build a sidewalk with the markers until he read about Hutton’s frightening experience in The Province.

Now, he thinks they should be returned to the Woodlands Cemetery from which they were removed.

His younger brother, David, 25, agrees.

“They should go back to the place where they came from.”

Yesterday Hutton remained outside while her friends packed her belongings for her.

But the goulies couldn’t resist a parting shot.

“I left the lights on when I went over to my mother’s last night. When I came back to pick up my things, the lights were off and the children’s toys were strewn down the stairs.”

Other tenants are seeking help.

“My sister is arranging for the church to become involved,” said Lucille Schneider. “She is calling in a group called the Prayer Warriors”.

*In April, 1966 my husband and I made a trip out west and camped at Cariboo R.V. Park in Burnaby, B.C. The purpose of the trip was to meet a second cousin to pursue a genealogy study of my maiden name severed text. My father and his three siblings were children at the Bernardo Home and all died not knowing of their background.*

*The youngest severed text was institutionalized at Riverview Hospital in Port Coquitlam, B.C. on severed text with a diagnosis of Huntington's disease. Prior to that he had made his home in Oyama, B.C. severed text died severed text a virtual pauper. While there I decided to see where he was interred and got the 'shock of my life.'*

*Evidently during the reign of Bill Vander Zalm it was decided out the front of St. Mary's Hospital (actually the writer is referring here to Queen's Park Hospital) should become a park / memorial garden. There is a bronze plaque on a stone hidden under a large evergreen to substantiate this. I understand this was advertised a Vancouver newspaper with a 90 days notice to the respective families (September 30, 1976). No attempt was made to contact my father, my mother and myself. (only family) in spite of the fact that the hospital had my parents address. The remaining stones were all removed with the understanding that they were to be put into a rock garden or similar. While there a security guard, severed text, along with the assistance of two patients, to see what became of the stone from my uncle's grave. He physically checked 178 tombstones in the garden shed with no luck. There are over 400 in the fountain. The total gravestones involved number 3090. My Uncle grave was in severed text which was close to the roadway into the Hospital.*

*it is apparent that some of them were used for patio stones as well as a base for a parking lot in the nearby area.*

*This is unheard of to desecrate a burial ground like this. The actual burial plots have sunken into near knee depth and the few stones that I seen under some of the trees are overgrown. See inclosed photos.*

*It is a shame that this man came to such hardship, firstly being a “Home Child” of Barnardos, being in a mental institution, and then having his grave abandoned and mutilated. Two of his brothers are buried here in **severed text** and it was my hopes that his headstone also could be put to rest along with theirs instead of being part of someones barbecue. British Columbia should be ashamed of it's self to have done something such as this.*

*I now understand that St Mary's Hospital (actually the writer is referring here to Queen's Park Hospital) is to be torn down. I doubt that such would be the case but should this missing tombstone show up I would like to follow through with the idea of having it placed with my brothers graves.*

Further to your correspondence with the Attorney General of British Columbia the Honourable Ujjal Dosanjh, QC, regarding the disposition of grave markers at the Woodlands/Queens Park Hospital in New Westminster, I am pleased to provide information respecting the history of this matter and the Province's commitment to have this matter addressed in an appropriate manner.

By way of background, the cemetery near Woodlands was operational from 1900 until its closure in 1958. Initiatives through-out the mid-1970s culminated in 1977 in the issue of an Order-in-Council to the Queens Park Hospital to accept the responsibility for the Maintenance of the closed cemetery. Just after that time, a decision was made by the Hospital Society to remove and dispose of the markers. At about the same time, the BC Buildings Corporation (BCBC) was created. Following the Society's decision respecting the markers, a memorial tablet and stone were installed in the old cemetery/memorial park in September of 1978.

Since that time a number of the markers removed from the cemetery have been found around the site, as well as off-site. Most, if not all extant markers have now been identified and either have been, or have been, in the process of being, moved to a storage facility on the Woodlands property. Although the remains of several thousands of people are buried in the cemetery, the old records are silent as to which graves had markers and which did not. Accordingly and regrettably, there is no way of knowing if there are other markers in existence. Never the less, areas are being searched to discover traces of any additional markers.

In late 1998, a steering committee was formed to deal with these cemetery issues. The steering committee is composed of representatives from the following stake holders: the BC Association for Community Living; Queens Park Hospital; The Ministry for Children and Families; and BCBC. Several steering committee meetings have been held thus far in 1999; during which, four main objectives have been established:

- . Development of a memorial garden on the cemetery site;
- . development of a memorial which recognizes those whose remains lie therein, and which demonstrates the historical significance of these individuals' lives.

- . development of a feature demonstrating that humankind has learned from these mistakes in the handling of persons with disabilities; and,
- . development of a plan to ensure the proper handling of all extant markers.

The steering committee also created a smaller working committee including several persons with special expertise in cemetery/memorial park design, and local history. This working committee has been tasked to resolve the issues arising from the four objectives noted above.

Enclosed for your reference are copies of minutes of committee meetings that have taken place to date. I have asked Gregg Sikora, the Corporation's Client Service Manager, to insure that you receive subsequent meeting minutes as well.

I would like to close with assurances that both committees, as well as the stakeholder groups which they represent, are committed to ensuring the remains of those individuals interred at Woodlands are dealt with in a manner respectful of their dignity and their memory.
